1. PROMOTION PERIOD/OVERVIEW: "The Tales of the Cocktail Sweepstakes" from Mizkan America ("Sweepstakes") begins on August 21, 2023, at 12:00 a.m. ("CT") and ends September 18, 2023, at 12:01 a.m. CT ("Promotion Period"). The Sweepstakes consists of two phases: the local seminar and the Tales of the Cocktail event. *An entrant must attend a Seminar in person in order to officially enter the Sweepstakes on-site*.

The Sweepstakes will_be conducted at three (3) educational presentations (each, a "Seminar") in three (3) cities during the Promotion Period: San Diego, CA; Chicago, IL; and Miami, FL. Each seminar will last for approximately one (1) hour or more and will be followed by a social hour (see Rule 4, below, for full details). An attendee must attend a seminar in person to fill out an official entry form on site for a chance to win the "Tales of the Cocktail" Sweepstakes.

The sponsor of this Sweepstakes is Mizkan America ("Sponsor"). By participating in the Sweepstakes, each Entrant ("Entrant" or "you") unconditionally accepts and agrees to comply with and to be bound by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission and processing of entries and the overall administration of the Sweepstakes.

- 2. ELIGIBILITY: Open to legal residents of the fifty (50) United States and the District of Columbia who are actively working in the bartending industry, were invited by Sponsor to attend one of its Seminars, and are the legal age of majority in the jurisdiction in which they reside, or 21 years of age, whichever is older. WAIVER OF JURY TRIALS AND CLASS ACTIONS: TO THE FULLEST EXTENT PERMITTED UNDER APPLICABLE LAW, YOU AND SPONSOR AGREE THAT IN ANY CIVIL LITIGATION THAT MAY BE FILED CONSISTENT WITH PARAGRAPH 8, BOTH PARTIES WAIVE THEIR RIGHT TO A JURY TRIAL, IF ANY. MOREOVER, BOTH PARTIES WAIVE ANY RIGHT TO BRING CLAIMS AS PART OF ANY CLASS ACTION OR PROCEEDING, AND ONE PARTY'S CLAIMS MAY NOT BE CONSOLIDATESD OR JOINED BY ANY COURT, AND RELIEF AWARDED TO ONE PARTY MAY NOT BE APPLIED TO AFFECT OTHER LITIGANTS.

10. GOVERNING LAW:

This Sweepstakes is subject to all applicable federal, state and local laws and regulations.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of the entrants, Sponsor or Released Parties in connection with this Sweepstakes shall be governed by and construed in accordance with the laws of the state of Illinois without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.
